Legal and Practical Implications of Reference-Based Pricing

There is a growing trend of third-party administrators employing reference-based pricing, where the TPA sets the price for a service not based on a party agreement, but instead, on the reference pricer's own price list, which can be based on a number of sources (percentage of Medicare, RBRVS, proprietary fee schedule). A TPA's use of reference-based pricing can result in significant amounts due from patients, because the amounts paid under reference-based pricing schemes are always significantly below a provider's billed charges. This session will address the legal implications of reference-based pricing, strategies for identifying TPAs employing reference-based pricing, and best practices for limiting the damages caused by use of reference pricing.
